MINUTES OF THE NEENAH COMMITTEE ON AGING

Thursday, May 19, 2022

Present: Vice Chair Joshua Kutney, and Committee members Herb Allen, Susan Antonneau, Kristi Branchford, Mary Nackers, and Mike Veith. (Four members were present in the Hauser Room and two members were present on GoToMeeting.) **Excused:** Pati Goodman. **Also Present:** City of Neenah Assistant Planner Carol Kasimor, Winnebago County Health Department Nurse Lori Duclon (GoToMeeting), and Winnebago County Aging and Disability Resource Center Supervisor Nicole Davis-Dawald (GoToMeeting).

Public Appearances:

Committee members introduced themselves, and welcomed new member Kristi Branchford.

Vice Chair Joshua Kutney discussed the co-location of Lakeland University at Fox Valley Technical College in Grand Chute (Door 15) in September. Among other benefits, the move is expected to better assist students at FVTC who wish to further their education.

Election of Officers:

On a motion by Allen, seconded by Antonneau and carried, Joshua Kutney was elected Chair of the Committee on Aging. (Kutney abstained.)

On a motion by Kutney, seconded by Antonneau and carried, Mike Veith was elected Vice-Chair of the Committee on Aging.

Approval of minutes of the April 21, 2022 meeting:

On a motion by Antonneau, seconded by Allen and carried, the minutes of the April 21, 2022 meeting were approved as distributed.

Discussion on 2022 School for Seniors:

Committee members discussed past School for Seniors events, which have partnered the City of Neenah with Lakeland University to offer learning opportunities that are educational, entertaining, and support the need for community for older adults. Past events have included a wide range of topics such as scams, memoir writing, and music. School for Seniors 2022 topics were suggested, including investment basics, advance directives, opera and the science of singing, and Zen drawing. Information fair topics could include Aging and Disability Resource Center information such as consumer scams and Medicare, the Neenah Animal Shelter, and movement and stretching with the Neenah-Menasha Y and/or Winnebago County Health Department. Possible locations were discussed, including Lakeland University at Fox Valley Technical College, Washington Park Shelter or other Neenah park shelters, schools or youth centers, and private event centers. Concurrent and breakout session formats were also discussed.

Adjournment: On a motion by Allen, seconded by Veith and carried, the meeting was adjourned at 10:05 a.m.
