MSC Volkman, Taylor, Ron Klatt was elected Chair of the Commission.

MSC Klatt, Steiner, Jack Speech was elected Vice-Chair of the Commission.

Approval of minutes:

MSC Speech, Volkman, the minutes of the July 28, 2021, September 22, 2021, January 26, 2022, February 23, 2022, and March 30, 2022 meetings were approved as distributed.

Discussion demolition and building permit reviews:

A) Review exterior building permit request for 106 W. Wisconsin Avenue:

Commissioners reviewed the proposal of Investment Creations, owner of 106 W. Wisconsin Avenue, to replace two of the four existing storefront windows with aluminum doors to allow access to the first and second floors. The property is in the Wisconsin Avenue Historic District, and requires Commission review for the issuance of an exterior building permit. Commissioners reviewed the historic use of the property and the proposed alterations of the storefront and found that there would not be an adverse effect on the property or the district.

MSC Gries, Taylor, the Commission approved the Certificate of Appropriateness for the request of Investment Creations to make exterior building permit alterations to 106 W. Wisconsin Avenue as described in the Community Development Memorandum of May 9, 2022.

Discuss education and information activities:

The First Hitch Draft Company is available for horse-drawn wagon tours on Saturday, September 17, 2022, the day of the Neenah-Menasha Inter-Tribal Pow Wow, at a cost of \$600.

MSC Klatt, Steiner, the Commission approved funding historic district tours with First Hitch Draft Company at a cost of \$600. (Taylor abstained.)

The Fox of the River Voyageur Canoe is available on Saturday, August 20, 2022, the day the Neenah Historical Society will be at the Neenah Farmers Market. The cost has not yet been determined.
