RE: S. Commercial Street Reconstruction – STP-Urban Application

Staff has submitted an STP-Urban application to WisDOT for the reconstruction of S. Commercial Street (Stanley Street – Tyler Street). This funding will offset a maximum of 80% of the cost of construction of selected projects. Since Neenah is within the Fox Cities Urbanized Area, submitted project applications are reviewed and ranked by the East Central Wisconsin Regional Planning Commission (ECWRPC). A funding pool of \$17,938,343 is available for the 2020-2025 program cycle for the Fox Cities Urbanized Area.

At the August 2019 meeting of the Transportation Advisory Committee, all of the ranked projects were reviewed. At the September 2019 meeting, a short-list of candidate projects was reviewed for final project selection. The goal of the project selection is to maximize the use of the funding pool for projects in the region. Ultimately, four projects were selected (see attached table). The S. Commercial Street project was one of the top two ranked projects and was one of the four projects selected for funding. The resulting cost-share percentage for those four projects is 72% STP funding - 28% Local funding.

As shown on the table, the estimated cost of the project is \$7,869,900. This does not include project design, which will be 100% City cost as has always been our practice. We are targeting a 2025 construction year with design starting in 2022. At the proposed funding level, the City's share of the project cost will be \$2,234,707. At the maximum funding level, the City share would have been \$1,573,800.

WisDOT and ECWRPC asked that the communities for the selected projects provide a formal indication of acceptance.

Staff recommends that Neenah accept the 2020-2025 STP-Urban grant award for the S. Commercial Street reconstruction with a 72% - 28% cost share.
