# **CORRESPONDENCE**

None.

#### **APPEARANCES**

Ms. McCoy presented an alternative perspective on the proposed installation of the proposed statue. She requested that the Commission use caution when considering this as it relates to Wisconsin and Neenah history.

Ms. Lang echoed Ms. McCoy's remarks indicating that we cannot assume historical correctness.

#### **MINUTES**

MSC Lawell / Vedder to approve the minutes of September 21 and October 12, 2017, all voting aye.

#### **BILL VOUCHERS**

Commissioner Zaretzke reviewed the vouchers for July and found them to be in order.

#### MISSION ACTION REPORT

The report was distributed earlier. The following items were discussed:

- Commissioner Galloway commented that we got lucky with the warm fall to have the grass growing at Washington Park and that he has had the opportunity to stop and talk to kids playing basketball (suggested Commissioner business cards). Commissioner Vedder indicated that he was very pleased with how great the park looks as you drive by.
- Recreation Superintendent Olson spoke of the Winter Olympics Celebration that is scheduled for January 13 at Washington Park to celebrate the new ice skating rink and the "Neenah Celebrate the Season" event happening downtown Neenah the weekend of December 1 3.
- Director Kading referred to a memo that was handed out prior to the Commission meeting indicating that the National Resource Damage Assessment Trustee Council has awarded the City of Neenah two grants-one grant for \$200,000 for the development of a float pier along the west shore of Arrowhead Park and the second grant for \$220,000 for nearshore and shoreline aquatic habitat restoration.

The second item is that the WI-DNR has responded to the Exemption Request for the closed Arrowhead Park landfill. The WI-DNR indicated that the City can move forward with the conceptual master plan



and begin zone specific design work that can be submitted for approval. This will ensure that the City only pays for what it designs and intends to build.

## **BUSINESS FOR CONSIDERATION**

#### 1) Reconsideration of Possible Donated Statue:

Commissioner Hillstrom – Read an email from Mayor Kaufert thanking the Commission for considering the possible donation of the statue.

Commissioner Galloway – Requested clarification of the Neenah Arts Board and their role. Art is in the eye of the beholder and cultural experiences are very important. Superintendent of Recreation Olson explained that the Arts Board has not directed to oversee art in public spaces.

Commissioner Vedder – Brought up the example of the proposed tank in Shattuck Park - Commission said no and it did not end up here. Presented information pertaining to the historical perspective of Chief Black Elk and a mountain is named in his honor in the Black Hills of South Dakota.

Commissioner Lawell – Historically inaccurate for the area to have a Plaines Indian in our location; Red Bird in High Cliff is a great example of a statue honoring our local Native American culture.

Commissioner Kelly – Offered a different perspective. We have art here (Lincoln, Washington, Jefferson) who have no local significance, but based upon the impact to our great nation we find them here. Could this be the case with this sculpture? Suggest that we approach the local Native American tribes and gain their input.

Commissioner Zaretzke - Beautiful presentation of art.

Commissioner Galloway – Endowments should be considered for long term maintenance and care.

Commissioner Hillstrom – Agreed that this item should be tabled to gather more information. Maintenance is an ongoing issue and should not be used as an excuse. This is a difficult and long lasting decision for the Commission

Superintendent Fink – Maintenance will require specialized knowledge and skill.

Commissioner Galloway – Feels that we have inadequate knowledge in specialized maintenance.

Commissioner Lawell – Is electrical part of this? Director Kading indicated that the statue is expected to be lit but needed further clarification as to who is responsible for electrical installation.

MSC Vedder / Louden to table this item to gather further information specifically related to the historical Native American perspective from local Wisconsin Tribes recognizing that the Commission must do its due diligence to protect all interested parties including the donor, the city and Wisconsin Tribes.

Commissioner Kelly - Questioned whether delaying this vote is wise.

Commissioner Zaretzke – While I do not have an historical perspective from the Native American Culture, the piece and proposed area look nice, and we should consider the intent of the donor.

Motion Carried -4 in favor, 1 against and 2 abstentions to table the decision until further information could be gathered.

# **December 21, 2017**

# Provide recreational experiences.

- The **new playground at Castle Oak Park** is open. Concrete sidewalk around the new playground has been completed and the engineered wood fiber surfacing has been installed. Landscaping will be completed next spring.
- Park staff was able to complete the landscaping around the **new playground at Carpenter Preserve**. The rubber playground surfacing is being schedule for installation in the spring.
- The Grinch Candy Cane Hunt was held Saturday, December 9 with 48 three-six years in attendance.

# Promote health and wellness.

- New sessions of adult (15+) Vinyasa Flow Yoga, Gentle Yoga-Pilates Fusion, Zumba®, and Strong by Zumba® will begin the first week of January. A 201 Mindfulness class is scheduled to begin at the end of January.
- The **Open Gym Basketball for Adults** will be on break over the holidays and resume the first week in January. On average, 18 adults attend the Monday & Wednesday evenings paying, at the door, \$2.50 each time attending. A gym supervisor sets up teams, based on those in attendance, with teams rotating playing time.


• Forestry staff has started removing **ash trees** in Memorial Park. Replacement trees are scheduled to be planted in spring.

## Strengthen safety and security.


- Forestry staff removed **dead elm trees**, **ash trees**, **and buckthorn** on the south side of the Carpenter Preserve Playground.
- Ice Rink Supervisors have been hired. Orientation sessions were held to review policies, procedures, safety, and acquaint staff with each of the three shelters.

## Support economic development.

• Loop the Little Lake – Neenah Bridge project is moving along nicely. In the pictures (12/18) below you will see pier number 6 which will support the observation deck and pier #7 which has been poured. The gigs are in place for piers #8 and 9 which will be drilled and driven yet this week. There are piers #10 & 11 to install plus the north abutment. Pier installation is approximately 1 month ahead of schedule. The first steel girders are to arrive Friday 12/22.

# BUSINESS ITEM #2: Fox River Loop the Lake – Neenah Amendment #1 Additional Inspection / Construction Services

A revised proposal for services rendered is attached. The need for additional inspection and construction services has been requested to cover the installation. The City and Graef worked out an arrangement for our Public Works Engineers to assist with specific engineering services to lower the overall financial impact. Staff has reviewed, is agreeable and recommends Amendment #1 and further recommends that Contigency Funds be used to cover these costs which are grant reimbursable.

<u>Action Needed:</u> A recommendation to accept Amendment #1 for Additional Inspection / Construction Services from Graef in the amount of \$7,400 NTE (labor) and \$900 (reimbursables) for a total of \$8,300 using contingency funds to cover the increased costs.

**ARROWHEAD PARK:** As we move into 2018 I am recommending that we begin preparing for 2019 construction work at Arrowhead Park. To date, we have secured \$420,000 in grant funds and \$380,000 in donated funds. The suggested construction components for 2019 include Millview Dr, carriage road, shore/near shoreline aquatic habitat restoration and boardwalk and activity building. Each of these components has been group into like activities so that we can bid out accordingly. Therefore, you will see separate agreements for each activity.

I have included a projected time line of activity for Arrowhead Park that may be helpful in seeing how all of the pieces fit together.

The scope of services includes preliminary design work (appr. 60%) and opinions of probable cost which will be presented to the commission and decision makers before moving into final design stage. This allows the commission and decision makers to have input in the design process.

\$400,000 has been budgeted for design work in 2018

#### BUSINESS ITEM #3: Arrowhead Park – Preliminary Design for Activity Building / Boardwalk

Having reviewed the agreement for preliminary design / opinion of probable costs for the activity building and board staff recommends accepting the agreement from SEH in the amount of \$49,480.

<u>Action Needed:</u> A recommendation to accept the agreement for Professional Services from SEH for preliminary design and opinion of probable costs of the activity building and boardwalk in the amount of \$49,480.

# BUSINESS ITEM #4: Arrowhead Park - Preliminary Design Millview Drive and Carriage Road.

Having reviewed the agreement for preliminary design / opinion of probable costs of Millview Drive and Park Carriage Road staff recommends accepting the agreement from SEH in the amount of \$75,000.

#### Dear Mike:

Per your request, Graef-USA Inc. (GRAEF) is pleased to provide this proposal to amend our services to the City of Neenah (Client). An executed copy of this proposal will amend our Agreement dated March 6, 2017.

This proposal is for professional services for Fox River Multi-Modal Bridge Crossing – Neenah Site - Detailed Design (Project). This proposal is subject to GRAEF's Standard Terms and Conditions, which were attached to our original proposal.

It is our understanding that the nature of the Project is the balance of the detailed design, construction document preparation and limited construction oversight for the installation of a multi-modal bridge crossing of the Fox River, Neenah Channel. The location of the crossing is behind the Plexus Global Headquarters building in downtown Neenah from the south shore to the north shore of the River at River Street immediately downstream of the existing railroad trestle.

The subject of this amendment is the additional inspection, primarily for piling installation in the month of November, as well as piling layout verification throughout the project duration. Our current contract has a very limited Construction Administration level of effort. It primarily includes: attending the Pre-Construction Conference and three (3) site visits by our structural engineer; two (2) site visits by our landscape architect; two (2) site visits by our electrical engineer; weekly ½ day site visits by a civil engineer (80 hours); and 2 hours per week for management by the Project Manager, review/responding to RFI's and shop drawings, and processing payment applications and any change orders. The construction phase was also anticipated to last 5-months.

At the Pre-construction conference, it was apparent that additional oversight/inspection and field survey verification of the piling installation would be necessary, as well as confirmation of proper girder placement. The schedule for the rebid contract is also



extended to 7-1/2 months (November to Mid-June). Based on the Contractor's submitted schedule, piling work on the Neenah Bridge is slated to last 68 days from 10/27/17 to 1/31/17 (14 weeks).

Per the prior discussions between yourself, Gerry Kaiser, and I; the City Public Works staff will be assuming responsibility for all inspection of the piling as of December 1, 2017 including any needed observation of pre-boring, pile driving, and concrete pours. GRAEF will provide piling installation inspection from the start of the work on October 30 through November 30, and provide piling layout verification and girder alignment verification from October 30 until completion of those activities. GRAEF will also provide initial instruction to City staff on piling inspection tasks and be available as a resource for questions during the City inspection period. Thus, our estimate would be approximately two (2) 4-hr days of on-site inspection per week for 5 weeks (40 hrs), then two (2) 2-hr days of piling/girder layout verification for the remaining 9 weeks (36 hrs).

For this Project, GRAEF proposes to provide the following additional Basic Services:

- Provide on-site inspection during piling installation operations from October 30 through November 30. Inspection to include:
  - Observe and verify pre-boring installation methods.
  - o Observe and verify pile driving installation methods.
  - o Observe and verify bearing requirements are met.
  - Observe and verify embedment depths are met.
- Provide piling layout verification until completion of piling installation.
- Provide girder alignment verification during girder installation.

GRAEF will endeavor to perform the proposed additional Basic Services per the following schedule:

• During pile installation operations scheduled between 10/27/17 and 1/31/17 on the Neenah Bridge, per the Contractor's original submitted schedule.

At your written request, GRAEF will provide a scope and fee for further Additional Services.

For this Project, it is our understanding Client will provide the following additional services, items and/or information:

- Pre-boring inspection beginning December 1, 2017
- Pile driving installation inspection beginning December 1, 2017.
- Abutment, piling, and pier concrete pour inspection beginning December 1, 2017.



For all additional Basic Services, Client agrees to compensate GRAEF as follows:

Construction Inspection: \$7,400 NTE (labor)

(plus reimbursables for mileage/travel estimated at \$900.)

To accept this proposal for additional Basic Services, please sign and date both enclosed copies and return one to us. Upon receipt of an executed copy, GRAEF will commence work on the additional Basic Services for the Project.



Dear Mr. Kading:

Thank you for the opportunity to continue to provide professional engineering services for the City of Neenah with this proposal for preliminary engineering of the floating boardwalk/fishing pier and Activity Center. This preliminary design is being completed according to the overall project timeline which calls for Phase 1 construction in 2019. (See attachment Arrowhead Park Project Timeline)

The City of Neenah is entering the next phase of design on two of the site amenity features identified in the master plan. The master plan calls for a boat activities building to be constructed near the loop the lake connection on the North East corner of the site as well as a floating fishing pier adjacent to the Neenah Slough on the North West edge of the site.

Due to their proximity to the lake shore and the fact that they are to be constructed on top of a capped PCB landfill, special permitting and approvals are required prior to constructing these facilities. Our proposal addresses that application and approval process as well as develops Preliminary designs of the proposed features.

In order to continue the vision for Arrowhead Park, it is important that the design of these two highly visible and dynamic amenities be properly designed and detailed to function as intended and to fit contextually into the park and its surroundings.

In the scope of services defined below SEH will describe the process we will use to deliver the preliminary design documents and begin the permitting process.

This phase of work will further develop the program of the boat activities building which was established with the City of Neenah and stakeholders back in February 2017. The scope of this work will include further refinement of floor plans, elevations, site plan, landscape plan and details, structural details, material selections, cost per square foot estimate of probable costs for the entire feature and a 3-Dimensional, rendering of the Activities Building for committee and council review and comment. It is our intention to propose Two (2) alternate designs for consideration with a recommendation by the design team as to the preferred option.

The scope of this work will include further refinement of boardwalk construction details, handrail design, ADA accessibility, site and waterfront shoreline connection plan, landscape plan and details, structural details, material selections, cost per square foot estimate of probable costs for the entire feature and a 3-Dimensional rendering of the floating fishing pier for committee and council review and comment. SEH will also engage Radtke contractors regarding constructability of the shoreline floating dock feature. This discussion should yield the appropriate path forward when detailing, permitting and constructing this in-water feature.

Short Elliott Hendrickson Inc (SEH®) is pleased to provide you this proposal for preliminary engineering of Millview Drive and the Carriage Road at Arrowhead Park. The NRDA Trustee Council (Council) approved funding for this project in November 2017. # TASK 2 - DESIGN ENGINEERING

# Task 2a - Baseline data and conceptual design

Stantec shall obtain and review existing available watershed data and gather site-specific information to support the project design. The proposed structures and placement locations will be based on concepts presented in the NRDA grant application. The following will be completed for this task:

- 1. Obtain existing bathymetric data (if available from Brennan or WDNR)
