The City of Neenah, as an Entitlement City, has been apportioned ARPA funding. In order to access and retain ARPA funding, the City is obligated to demonstrate the use of the funds within eligible categories' defined by the ARPA legislation. Funds must be spent or obligated by end of calendar year 2024. Funds obligated but unspent by end of calendar year 2024 must be disbursed by the end of calendar year 2026.

The Finance Department staff, both independently and in consultation with Baker Tilly, has concluded that the City of Neenah is eligible to access and retain ARPA funding through the use of revenue replacement. Both Finance Director Easker and Deputy Comptroller Kahl walked the Council through the decision making process and how that conclusion was made. Finance staff also explained the restrictions on how the funds are to be used.

There was discussion on investment opportunities until such time as the funds are disbursed.

The Council was appreciative of the work that went into securing ARPA funding for the city.

- Matthew Zodrow (1305 Cty Road JJ, Neenah) appeared to the commission to enquire about the City of Neenah amending the Boundary Agreement with the Town of Neenah and his property becoming city growth area and the potential ramifications to himself. Deputy Director Schmidt clarified that bringing his property into the city growth area does not allow the city to forcibly annex his property. It will be possible for him to request annexation at any time during the agreement if he should choose to do so. Mr. Zodrow was satisfied with this response.

### **Action Items:**

A. Comprehensive Plan Amendment – Future Land Use – Tullar Road/Oakridge Road

The Community Development Department has received a request to amend the City's Comprehensive Plan and Future Land Use Map for an area at the intersection of Tullar Road and Oakridge Road. The proposal is to amend the Future Land Use map designation for this area from Residential Neighborhood Investment Area to Mixed Use.

Director Kaiser asked if changing from Residential Neighborhood Investment Area of Mixed Use is a stepping stone for moving towards making the entire areal I-1. Deputy Director Schmidt indicated that by classifying the area as Mixed Use the city has the freedom to allow the area to develop naturally over the next 5-10 years. That could be more industrial, or it could be other types of development.

MSC Kaiser/Andrews, the Plan Commission approves Resolution 2021-1 and recommends Common Council approve Ordinance no. 2021-15 amending the Comprehensive Plan 2040 and Future Land Use Map. All aye. Motion passed.

**B. Rezoning** - 1480/1490 Oakridge Road – Temp I-1 District to I-1, Planned Business Center District
The subject property located on the southeast corner of Tullar Road and Oakridge Road was recently annexed into the City from the Town of Neenah. The property (including the adjoining Oakridge road right-of-way) is approximately 4.5 acres in size. The applicant has plans to redevelop the property into a light industrial and office use, which would be permissible in the I-1, Planned Business Center District.

The City of Neenah is submitting a CSM to dedicate public right-of-way for the extension of Schootinstar Drive west, to connect to Armstrong Street. The land was recently annexed into the city. In addition to the dedication of public right-of-way, the CSM also creates two outlots on the north and south sides of the proposed right-of-way. There are no plans for the use of these outlots at this point.

## An Ordinance

The Common Council of the City of Neenah, Wisconsin, do ordain as follows:


- **SECTION 1.** Pursuant to section 62.23(2) and (3), Wisconsin Statutes, the City of Neenah is authorized to prepare, adopt, and from time to time amend, a Comprehensive Plan as defined in sections 66.1001(1)(a) and 66.1001(2) of the Wisconsin Statutes.
- **SECTION 2.** On December 20, 2017, the City of Neenah Common Council adopted the *Comprehensive Plan Update 2040* (Ordinance No. 2017-19) which presents a strategy to manage growth and development of the City through the year 2040.
- **SECTION 3.** The City of Neenah Plan Commission, by majority vote of the entire Commission as recorded in its official minutes, adopted Resolution 2021-1, recommending to Common Council the adoption of the proposed Amendments to the City of Neenah Comprehensive Plan Update 2040 as depicted in Exhibit A.
- **SECTION 4.** The City has noticed public hearings to make comments on the proposed Amendment to the *Comprehensive Plan Update 2040*, in compliance with the procedures in Section 66.1001(4) of the Wisconsin Statutes.
- **SECTION 5.** The Common Council of the City of Neenah, Wisconsin, does, by enactment of this ordinance, formally adopt the Amendments to the *Comprehensive Plan Update 2040* as depicted and described on Exhibit A, change the future land use designation for land located on the southeast and northeast corner of Tullar Road and Oakridge Road from Residential Neighborhood Investment Area to Mixed Use.

**SECTION 6.** Severability. In the event any section, subsection, clause, phrase or portion of this ordinance is for any reason held illegal, invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remainder of this ordinance. It is the legislative intent of the Common Council that this ordinance would have been adopted if such illegal provision had not been included or any illegal application had not been made.

**SECTION 7. Effective Date.** This ordinance shall take effect upon passage by a majority vote of the members-elect of the Common Council and publication as required by law.

## **AN ORDINANCE**

The Common Council of the City of Neenah, Wisconsin, do ordain as follows:


**Section 1.** Section 26-123 of the Neenah Municipal Code pertaining to zoning districts, and the map therein described, is hereby amended by rezoning approximately 0.10 Acres of land located at 307 High Street from the I-2, General Industrial District to the R-2, Two-Family Residence District. The property is more particularly described as follows:

Lot 1 and Lot 2 of CSM No. 5899, being part of the SW ¼ of the SE ¼ of Section 20, Township 20 North, Range 17 East, Town of Neenah, Winnebago County, Wisconsin, including the to the centerline of Oakridge Road.

Parcel ID: 807-0900-00-00 and 807-0901-00-00

- **Section 2.** Severability. In the event any section, subsection, clause, phrase or portion of this ordinance is for any reason held illegal, invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remainder of this ordinance. It is the legislative intent of the Common Council that this ordinance would have been adopted if such illegal provision had not been included or any illegal application had not been made.
- **Section 3.** Repeal and Effective Date. All ordinances or parts of ordinances and resolutions in conflict herewith are hereby repealed. This ordinance shall take effect from and after its passage and publication.

# SECOND ADDENDUM TO THE COVID-19 CORONAVIRUS FIRE SERVICE MUTUAL AID PACT

THIS SECOND ADDENDUM ("Second Addendum") shall serve as an understanding and agreement to extend the existing COVID-19 Coronavirus Fire Service Mutual Aid Pact originally entered on March 27, 2020 ("Pact") and extended by Addendum ("Addendum") through December 31, 2021, between the following municipalities (jointly referred to as "Members") located within Winnebago County and/or adjacent to Winnebago County that provide fire protection:

City of Oshkosh, City of Kaukauna, Town of Grand Chute, City of Appleton, Neenah-Menasha Fire Rescue, and Village of Fox Crossing.

WHEREAS, the Members entered into the Pact on March 27, 2020 and extended the Pact through December 31, 2021. The parties again desire to extend the Pact to December 31, 2023 as the effects of COVID-19 have continued to impact staffing availability as well as calls for service.

NOW THEREFORE, the Members hereby incorporate the previous statements and mutually agree to the following:
