Public Appearances: No public appearances.

Approval of minutes:

MSC Speech, Volkman, the minutes of the May 11, 2022 meeting were approved as distributed.

Discussion demolition and building permit reviews:

A) Review exterior building permit request for 106 W. Wisconsin Avenue:

Commissioners had previously approved a Certificate of Appropriateness for the alteration of the north and south facades at 106 W. Wisconsin Avenue.

The owner of the property is proposing to revise the original site plan to retain the existing concrete sill on the front storefront and utilize it as a step into the building at the location of the entrances previously approved, at the far west and east sides of the building. A handicapped accessible entrance will be located at the rear of the building. The two front entrances to the building are proposed to be recessed, with metal or wood framed doors.

The Commission discussed the proposed changes. Commissioner Gries recommended that the doors be full-lite doors.

MSC Gries, Taylor and carried, the Commission approved the Certificate of Appropriateness for the revised site plan dated June 8, 2022, contingent on the verification of the style of the entrance doors to be full-lite doors.

Discuss education and information activities:

The Fox of the River Voyageur Canoe LLC is available for historic tours on Saturday, August 20, 2022 at the Neenah Farmers Market. Neenah Historical Society is sponsoring History's Mysteries at the market.

MSC Taylor, Speech, the Commission approved funding historic tours with Fox of the River Voyageur Canoe Company at a cost of \$400, contingent on review by the City Attorney and obtaining a certificate of insurance.

Announcements and future agenda items:

Commissioner Jim Taylor reported that the Menasha Landmarks Commission and the Menasha Historical Society have invited the Neenah Landmarks Commission and the Neenah Historical Society to work together on the commemoration of the 150th anniversary of incorporation of the Cities of Neenah and Menasha, in 2023 and 2024, respectively. Commissioners agreed on a collaboration, and Dan Steiner and Ron Klatt volunteered to be liaisons for the effort from the Neenah Landmarks Commission.
