## Public Works:

1. Pay Estimate No. 1 for Contract 1-21: Director Kaiser explained this work is for Marathon Ave Sanitary, Water Main and Street construction project. He stated that all of the work on this pay estimate is for sanitary sewer. Director Kaiser noted that a correction was made to three of the line items. Furnish and Install Standard Manholes should be 16.11, Remove Sanitary Manhole should be 2.0, and Adjust Sanitary Manhole should be zero. The result is a decrease in in the amount of \$481.22 making the pay estimate \$47,344.68. Director Kaiser requested approval of Pay Estimate No. 1 for Contract 1-21 Sanitary, Water Main and Street Construction on Marathon Avenue to Donald Hieptas & Sons, Inc., in the amount of \$47,344.68.

2. Change Order No. 1 for Contract 2-21: Director Kaiser explained this contract includes work being done on Fairview Avenue and Laudan Boulevard. This change order was to provide temporary water service for residents on Fairview Avenue. Director Kaiser stated that during excavation it was discovered that there was not going to be enough room in the trench to lay the new water main and keep the existing water main without substantial rock excavation. Director Mach discussed

Director Easker asked if this method has ever been used on other city projects. Director Kaiser stated that no. Director Easker asked if this method may be done more in the future due to the cost savings. Director Kaiser stated that it is something that Director Mach will be possibly be looking into.
