Award Contract 6-17 Concrete Pavement and Sidewalk Repair: Dir. Kaiser distributed the bid tabulation for Contract 6-17 Concrete Pavement and Sidewalk Repair. There was (1) bidder. There are normally (2) bidders and typically (3) to (4) however workload of other contractors kept them from submitting bids this year. He recommended awarding Contract 6-17 to the low bid from Al Dix Concrete, Kaukauna in the amount of \$193,625.00. Al Dix is a new contractor for the City. In checking with other communities that have used them, Dir. Kaiser has found that their work is good. He compared the winning bid to last year's and the numbers are in line. MSC Kaiser/Haese to recommend Council award Contract 6-17 for Concrete Pavement and Sidewalk Repair to the low bid from Al Dix, Kaukauna in the amount of \$193,625.00, all voting aye.

Award Contract 7-17 HMA Pavement Repair: Dir. Kaiser distributed the bid tabulation for Contract 7-17 HMA Pavement Repair. There were (2) bidders, MCC and Northeast Asphalt. The last 3-4 years Northeast Asphalt was our only bidder. It is good to see other bidders. He recommended awarding Contract 7-17 for HMA Pavement Repair to the low bid from MCC, Inc. in the amount of \$137,765.76. This work will be a direct cost to the homeowners or part of the escrow. All the work is complete except cleaning and sealing concrete pavement joints and asphalt patchwork. MSC Kaiser/Bates to approve Pay Estimate No. 2 for Contract 4-17 Industrial Drive Concrete Street Rehabilitation to Sommers Construction, Inc. Shiocton in the amount of \$84,063.75, all voting aye.
