Midpark Drive, Appleton, WI 54915-3669 in the amount of \$81,035.80. Dir. Kaiser stated that the work is complete but not ready for a final payment at this time. Ald. Bates wanted to know how much was paid to date. Dir. Kaiser said \$194,385 has been paid but this could go into 2019 with weather issues. Ald. Hillstrom mentioned the water leak in front of the Boys and Girls Brigade building. Dir. Kaiser said that it is being worked on and done shortly and this repair will be on the 2019 project list. Maintaining the cold patch through the winter is tough with weather changes.
