Kading recommended approval of payment of Pay Request #4 for Contract PR01-17 the Fox River "Loop the Lake" Neenah Bridge Crossing Project to Pheifer Brothers Construction Company Inc. in the amount of \$132,272.30. This is approximately \$10,000 higher than what is listed on page 2 of the pay request (\$122,614.66) due to an overage of retainage that exceeds 5% that the city needs to return to the contractor. Dir. Kaiser concurred with this indicating Public Works holds 5% retainage for the first 50% of the project. Dir. Kading advised the structure is 90% complete and this payment brings us to 72%. He briefly reviewed a spreadsheet he prepared outlining the contingency for this project showing grant dollars, donations and city impact. Mayor Kaufert questioned a charge for 3/8" washers @ \$50 each on an invoice in the packet of materials. Ald. Bates indicated that may be the price per box. Dir. Kading indicated he would check and get back to the Board.
