Discussion of sustainability plan update:

Follow-up on potential farmers market presentations for this summer: Wild Ones may be interested in collaborating on a presentation on native plants and Fox/Wolf Watershed Alliance has been contacted regarding a stormwater presentation. Becky contacted the Neenah High School Eco Club advisor, who will follow up on potential collaborations between the club and the SNC.

Flo Bruno reported that volunteers will take part in the area-wide cleanup near and in the water around Doty Island on May 3, 2025. Frank Cuthbert reported that plans are being made by the Neenah Parks and Recreation Commission for temporary grazing by sheep to reduce non-native plants in the Carpenter Preserve.
