**Public Appearances:**

Lori Duclon reviewed upcoming Wellness Plus class offerings including Tai Chi and Stepping On. Free Covid-19 test kits are available in Winnebago County, including at the Health and Human Services Building, 211 N. Commercial Street, while supplies last. RSV (respiratory syncytial virus) is also of concern to older adults, and testing is also available and encouraged.
