Present: Chair Joshua Kutney and committee members Susan Antonneau, Kristi Branchford, and Pati Goodman. **Also Present:** Kate Yates, YMCA of the Fox Cities ForeverWell Program Director, City of Neenah Assistant Planner Carol Kasimor; Marcy Griffen, Neenah, and Jim Lauer, Neenah.

Public Appearances:

Kate Yates reported on the insurance programs that will be available in 2025 that support senior memberships at the Y, and the various levels of activities for seniors and their cost. Social and educational programs are free of charge, some programs have a cost of \$3, and the Senior Program Pass (which City of Neenah and Winnebago County budget funds support) is \$33 per month.

Marcy Griffen introduced herself and explained her background.

Kristi Branchford discussed Valley VNA activities and its history.

Approval of minutes of October 31 and November 21, 2024 meetings:

MSC Branchford, Kutney, the minutes of the October 31 and November 21, 2024 meetings were approved.

Discuss committee purpose and future direction:

Committee members discussed committee history and structure. There was also discussion about community calendars and how they might serve the older adult population, and the YMCA of the Fox Cities and how it may serve this population in the future. Committee members suggested that the group build on its strengths, learn more about resident needs and wants, expand its purpose, establish priorities, and determine strategies for accomplishing its objectives. Next steps may include establishing a more formalized committee framework, undertaking a resident survey, and meeting with the mayor on an annual basis.

Transportation for older adults will also be a topic for a future meeting.
