Committee members discussed timing and location for the 2023 School for Seniors, considering the Day in the Park to be held September 12, 2023 in Fritsch Park. Availability of St. Mark's Church (last year's location) will be determined for September 29.

Suggested sessions included scams, resource table topics, housing options, and topics of interest from Lakeland University faculty.
